


### Airspace Change

At LLA we are currently working on our next phase of airspace change which involves Performance Based Navigational procedures on one of our westerly departure routes.

The Civil Aviation Authority require all airports to follow a regulatory process to do this which is detailed in the CAA's publication CAP1616. LLA submitted documentation to the CAA in January 2017 as part of stage 1 of this process, you can view these documents [here](#).

We are now working through stage 2 of the process which involves the development and assessment of draft designs, this is being done with the input and feedback of the Airspace Change Focus Group which comprises of local community representatives. Public consultation is expected to take place in 2019.



**99%** of departing aircraft complied with departure procedures in Dec and January.

An aircraft is considered to comply with departure procedures if it remains within the Noise Preferential Route corridors, up to an altitude of 3,000ft during the day or 4,000ft during the night. On our RNAV route (26 Match/Detling), aircraft must remain within the corridor until an altitude of 4,000ft day and night.

A Continuous Descent Approach (CDA) is conducted by an aircraft on arrival. As an aircraft descends from 5,000ft, there should be no period of level flight longer than 2.5 nautical miles. This keeps the aircraft higher for longer and reduces the noise disturbance at ground level. This winter we have seen periods of strong winds which has caused CDA compliance to reduce slightly.

**88%** of arriving aircraft used Continuous Descent Approach procedures in Dec and January.
