The following updates to matters arising were noted and are replicated below to aid members of the public:

- Pavilion workplace risk assessment to be undertaken once office and store operational.

- Both Asset Checker and Cleaner now in place. 3-month reviews due at end March 2021.
- Christmas/thank you cards seem to have been well received.
- Caretaking/health & safety checks being monitored and undertaken by council staff on a temporary basis.

- 1. Staff Overtime
 - a. It was RESOLVED to pay the Parish Assistant for 11 hours of overtime undertaken in the last quarter to support the re-opening of the pavilion.
 - b. It was **RESOLVED** to pay the Parish Clerk for 245 hours of overtime undertaken in the last 4 months to support the re-opening of the pavilion. All to be funded via the previously approved S106 grant.
 - c. The staffing committee expressed thanks to members of staff for their efforts to deliver this project.

2. Contract Amendment for Parish Clerk

It was **RESOLVED** that council would issue a minor amendment to the contract for the clerk, to reflect the multi-location now that the parish office will be coming online.

It was **RESOLVED** to continue with the quarterly home office allowance.

It was **RESOLVED** to review the position in 6 months.
